Central University of Andhra Pradesh holds a special place in the Indian University System. It was born out of a promise made by Government of India to fulfill the aspirations of people of Andhra Pradesh on the eve of bifurcation of the erstwhile composite state of Andhra Pradesh into Telangana and Andhra Pradesh. The University is established in 2018 in the district headquarter town of Anantapuramu in the Rayalaseema region of Andhra Pradesh. The Region has immense historical significance as it forms the part of the Vijayanagara Empire ruled by majestic king Sri Krishnadevaraya, among others. The folklore of the region is richly filled with the stories of Sri Krishnadevaraya's people centric rule and several welfare measures. That apart the region is also known for its mineral deposits and salubrious climate of the Deccan Plateau. The region also is known for sericulture and horticulture crops. As a feather in the cap the global auto major KIA started its operations in a green field project, just 60 KMs away from Ananthapuramu city. Further Ananthapuramu is also a prominent educational hub with higher educational institutes such as Sri Krishnadevaraya university, Jawaharlal Nehru Technological University, Sri Sathya Sai Institute of Higher Learning, Government Medical College and a century old Government Arts College, apart from a host of engineering colleges.

The University heralds a new era in the sphere of higher education. With innovative socially and culturally relevant academic programmes, the university is poised for rapid growth in the years to come. Transforming students into knowledgeable and responsible citizens of the nation through value-based education with an emphasis on interactive learning coupled with hand-on experience is the hall mark of this university.

The CUAP has introduced several new programmes which are running smoothly in the transit campus of the university as the permanent campus of CUAP is still under construction. At present the University is offering 4 UG and 9 PG Programmes with a total 484 students on rolls for various programmes.

The university is running its academic programmes by hiring superannuated Faculty, Senior faculty, Distinguished faculty, Guest faculty and Experts from the various organizations/institutions in the relevant fields.

The Government of Andhra Pradesh, State NSS Cell, Higher Education Department, Govt. of India accorded the permission to establish the NSS Cell. The University established the NSS Cell with two units of 100 students each to begin on its premises at Transit Campus-II, Bellary Road, Ananthapuramu.

From the Vice Chancellor Desk/Forward:

The Central University of Andhra Pradesh continues its journey towards its noble goals in the arena of education. In addition to having well-calculated strategies of administration providing fully advanced infrastructural facilities on campus is also vital to consider an institute well flourished. With pride I can state confidently that the Central University of Andhra Pradesh has advanced tremendously this year in all respects. Students and faculties have organized and took part in many curricular, co-curricular and extra-curricular activities.



It was an honour to have eminent personalities like Prof. Shanthisree Dulpuri Pandit, Hon'ble Vice Chancellor of Jawaharlal Nehru University, Delhi and Prof. P. Balaramam, Former director, IISC, Bangalore, with us for special lectures. Hon'ble Vice Chancellor Ma'am emphasized the role Sri Sardar Vallabhbhai Patel played in the Independence of India. She encouraged the students to read and know their history and their leaders.

Central University of Andhra Pradesh Vice Chancellor Prof. S.A. Kori called on Hon'ble President of India Srimati Droupadi Murmu, Visitor of the University, on 13 March 2023 at Rashtrapati Bhavan in New Delhi. Prof. Kori apprised the Hon'ble President of the progress of the University established at Ananthapuramu in 2018-19 as promised by Government of India to fulfil the aspirations of the people of Andhra Pradesh on the eve of the bifurcation of the erstwhile composite state of Andhra Pradesh into Telangana and Andhra Pradesh. The following points were brought to the notice of the Hon'ble President.

- At present the University has more than 500 students from 28 Indian States and construction work is in progress on its permanent campus at Janthaluru, Ananthapuramu. The Vice Chancellor presented a copy of the master plan of the new upcoming state-of-the-art smart campus to Hon'ble President.
- With the support of ISRO, the University is planning to set up an Observatory Centre on its upcoming permanent campus. Hon'ble Vice Chancellor requested DRDO to set up a Centre of Excellence by way of an Incubation Centre at CUAP to conduct research on prototype fuel cells and nano battery sensors and offer training to dropouts.
- The University also proposes to establish hostels for SC and OBC students with support from the Ministry of Social Welfare and Justice and a hostel for ST students with support from the Ministry of Tribal Affairs.
- Department of Science and Technology, Government of India, and STI Hub (Science Technology and Innovation) are working with CUAP on creating awareness among the vulnerable groups in rural areas about use of pesticides and agriculture marketing and imparting basic computer knowledge by establishing a centre for outreach activities. The proposed Sports Centre too will boost sports activity in the region.
- The University made a thorough study of NEP 2020 and brought in appropriate changes in its curricula in accordance with the requirements of the Policy.

- The University conducted two major surveys for Government of Andhra Pradesh, the first on the Girl Child and the second on the Boya (Valmiki) Community in the region.
- The University hosted an insightful discussion on the book “Modi@20: Dreams Meet Delivery” on 4 August 2022. Chief Guest Smt. Annpurna Devi, Hon’ble Union Minister of State, Ministry of Education, Govt. of India, and Guests of Honour Shri A.S. Kiran Kumar, Padma Shree awardee and former Chairman ISRO, and Smt. Shobhana Kamineni, Vice Chairperson of Apollo Hospitals, addressed the participants. The students and teachers actively participated in the discussion.
- The Central University of Andhra Pradesh has adopted six villages under the Unnat Bharat Abhiyan. Under the Ek Bharat Sresht Bharat programme, it has signed an MoU with the Central University of Punjab and has successfully got two anthologies of Telugu poems translated into Punjabi with three more in the pipeline. The University also conducted a series of programmes as part of Azadi Ka Amrit Mahotsav including a “Har Ghar Tiranga” programme in Janthuluru and Reddipalli, two of the villages adopted by the University, a poster exhibition “Wall of Horrors” commemorating “Partition Horrors Remembrance Day,” a second one on India’s Freedom Struggle, and another on “Electoral Participation and Political Empowerment.” In addition, a seminar “Preamble, People, Politics” was also organized. The students and staff also conducted a flag march from the Clock Tower to the Municipal Office at Ananthapuramu town which was highly appreciated by the public and received widespread coverage in the media.

Hon’ble President appreciated Prof. S.A. Kori and his proactive efforts to make CUAP an HEI of excellence.





Dr. Ambedkar Centre for Excellence(DACE):

The Central University of Andhra Pradesh has been sanctioned with Dr Ambedkar Centre of Excellence by the Ministry of Social Justice and Empowerment, Gov. of India. for the year 2022-23. The basic objective of Dr. Ambedkar Centre for Excellence (DACE) is to provide high quality free coaching facilities to the Scheduled Caste students for the Civil Services examinations, to be conducted by Union Public Service Commission (UPSC) from 2023 onwards. The Government of India aims to achieve the social justice goal by providing inclusive opportunities through DACE Scheme.

Dr. Bhimrao Ramji Ambedkar (1891-1956), fondly known as Babasaheb, is one of the most illustrious sons of India and a great National Leader. He is considered as the champion for the Dalit cause, an erudite scholar, extraordinary statesman and a visionary who contributed greatly to the building of the modern Nation. Dr. Ambedkar left an indelible impression in the history of India as a messiah who unfettered the oppressed classes that were path-breaking in its essence and strived towards the monumental endeavors of freedom. He was the Chief Architect of the Constitution of India, wherein Babasaheb left emancipatory provisions for the justice and empowerment of the oppressed classes. He is the symbol of the struggle for justice and empowerment of the weaker and downtrodden population in India and laid the foundation stones of building a just society. Babasaheb's groundbreaking ideas led to the formation of the Reserve Bank of India during British rule. As a Labour leader, he promoted the revolutionary idea of "fair condition of life of labour" as opposed to "fair condition of work" which provided the outline of the future labour laws in India. Babasaheb was also a champion of the cause of gender parity as he initiated reforms for lessening of working hours to 48 hours per week, removed the ban of engaging the women in various forms of employment and coded the principle of "equal pay for equal work" irrespective of gender. His idea of the Hindu Code Bill is of emancipatory nature. Babasaheb also left a lasting impression as a social reformer through his role in the movements like Mahad Satyagraha, the Anti-Khoti movement and the Dalit Buddhist movement.

In pursuance of the decisions of the Governing Body, the scheme is aimed to establish Dr. Ambedkar Centre for Excellence in at least 30 Central Universities, one from every State/UT of India. Through the Scheme, the Centre shall empower Scheduled Caste students in competitive exams by providing the best and free coaching facilities.

CUAP provided state of art facilities to students and 99 students are enrolled for coaching out of sanctioned strength 100. The centre was inaugurated on 1st October 2022 by Sri Talari Rangaiah, Hon'ble Member of Parliament from Ananthapuramu Free Coaching Programme of the Central University of Andhra Pradesh at the University interim campus on JNTU Road, Ananthapuramu. While inaugurating the Programme the Mr. Rangaiah promised to take the hostel facility and stipend issues of the students of the Programme to the Minister of Social Justice and Empowerment, Government of India and do his best to facilitate the students further.

The Guest of Honour for the event Dr. Fakkeerappa Kagineili, IPS, Superintendent of Police, Ananthapuramu District advised the students to make use of the digital library established by SP office and volunteered to take classes occasionally and also inspired the students for preparation of Civil Services Free Coaching Programme of Dr. Ambedkar Centre for Excellence (DACE) in the Central University of Andhra Pradesh.

Prof. S. A. Kori, Vice Chancellor, Central University of Andhra Pradesh, Ananthapuramu while presiding over the Inaugural Function, explained about the need to empower the marginalized communities like Scheduled Casts and promised to explore the possibilities to get funding from Philanthropists /Donors for the hostel facility or stipend of the students of Civil Services Free Coaching Programme. Prof. M. D. Bavaiah, Programme Coordinator welcomed the Guests for the Inaugural Function and Prof. G. Ram Reddy, Dean in-Charge & Nodal Officer, Dr. Ambedkar Centre for Excellence (DACE) explained about the importance of Civil Services Free Coaching Programme for the empowerment of Scheduled Cast Students while Prof. Prof. Hanuman Kennedy, Controller of Examinations, Central University of Andhra Pradesh, has proposed Vote of Thanks.

UNIVERSITY BODIES/AUTHORITIES:

The University has certain regulatory bodies responsible for its functioning. These include Executive Council and the Finance Committee.

EXECUTIVE COUNCIL:

The Executive Council is the principal executive body and have the powers to make the appointments of the members of the faculty and other non-teaching on the recommendations of the Selection Committees, and fix their emoluments and define their duties. The Executive Council is also vested with the powers to maintain discipline among the teaching and non-teaching employees in accordance with the provisions of Statutes and Ordinances and manage and regulate the finance, accounts and other administrative affairs of the University.

EXECUTIVE COUNCIL MEETING:

During the year Executive Council deliberated upon various administrative and academic matters and took important decisions. It also considered and approved action taken by the Vice Chancellor on matters of Report of Space Programme being taken up at CUAP, Disposal of Used Answer Scripts in Examination Section, Issues of CUAP at Permanent Campus, Appointment of doctors on adhoc etc in exercise of the powers conferred upon him in terms of the Statutes/Ordinances. The Council also approved the action taken by the Vice Chancellor in approving the recommendations of various Selection Committees for faculty and non-teaching appointments.

"The invaluable contributions of Sardar Vallabhbhai Patel in building a strong nation have to be remembered by each citizen of India," she continued.


Her speech was part of the celebrations of the Ekta Diwas at the Parliament, commemorating the birth







SCHEDULE: 23 SIGNIFICANT ACCOUNTING POLICIES

1. BASIS FOR PREPARATION OF ACCOUNTS

- 1.1 The accounts are prepared under the Historical Cost Convention unless otherwise stated and generally on the accrual method of accounting.

2. REVENUE RECOGNITION

- 2.1 Fees from Students (except Tuition Fees), Sale of Admission Forms, Royalty and Interest on Savings Bank account are accounted on cash basis. Tuition Fees collected separately for each semester is accounted on accrual basis.
- 2.2 Income from Land, Buildings and Other Property and Interest on Investments (except of Endowment Funds) are accounted on accrual basis. Investments against most individual Endowment Funds are small and moreover, presenting the income with inclusion of accrued interest would also not reflect correctly the amount actually available for expenditure on the objects of the respective funds.

3. FIXED ASSETS AND DEPRECIATION

- 3.1 Fixed assets are stated at cost of acquisition including inward freight, duties and taxes and incidental and direct expenses related to acquisition, installation and commissioning.
- 3.2 Gifted and Donated assets are valued at the declared value where available if not available the value is estimated based on the present market value and the physical condition of the asset. They are set-up by credit to Capital Fund and merged with the Fixed Assets of the University. Depreciation is charged at the rates applicable to the respective assets.
- 3.3 Fixed assets are valued at cost less accumulated depreciation. Depreciation on fixed assets is provided on written down value method, at the following rates:

4. INTANGIBLE ASSETS

- 4.1 **PATENTS:** The expenditure incurred from time-to-time (application fees, legal expenses etc.) for obtaining Patents is temporarily capitalized and shown as a distinct head in the Balance Sheet. If applications for patents are rejected the cumulative expenditure incurred on the particular patent is written off to the Income & Expenditure Account in the year the application is rejected. The expenditure on Patents granted is written off over a life of 9 years on a conservative basis.
- 4.2 **ELECTRONIC JOURNALS (E-Journals):** Electronic Journals (E-Journals) are separated from Library Books in view of the limited benefit that could be derived from the on-line access provided. Though E-journals are not in a tangible form, they are temporarily capitalized in view of the magnitude of expenditure and the benefit derived in terms of perpetual knowledge acquired by the Academic and Research Staff; Depreciation is provided in respect of E-journals at a higher rate of 40% as against depreciation of 10% provided in respect of Library Books.
- 4.3 **COMPUTER SOFTWARE:** Expenditure on acquisition of software has been separated from computers and peripherals, as apart from being intangible assets, the rate of obsolescence in respect of these is very high. Depreciation is provided in respect of software at a higher rate of 40% as against depreciation of 20% provided in respect of Computers & Peripherals.
- 4.4 **SUBSCRIPTION OF JOURNALS:** The subscriptions for more than one Journal in a single payment for a period of one year or less for which subscription periods are differently overlapped with the current year are booked as current year expenditure.
5. **STOCKS:**
- 5.1 Expenditure on purchase of chemicals, glassware, publications and other stores is accounted as revenue expenditure, except that the value of closing stocks held on 31 March is set up as inventories by reducing the corresponding Revenue Expenditure on the basis of information obtained from Schools and Departments.

6. INVESTMENTS:

- 6.1 Long term investments are carried at their cost or face value whichever is lower. However, any permanent diminution their value as on the date of the Balance Sheet is provided for.
- 6.2 Short Term investments are carried at their cost or market value (if quoted) whichever is lower
- 6.3 Savings Bank Accounts with auto sweep facility, generate interest according to the duration for which the funds are auto swept from time to time. The interest income in such saving bank accounts is accounted for only on receipt basis.

7. GOVERNMENT AND UGC GRANTS:

- 7.1 Government Grants and UGC grants are accounted on realization basis. However, where a sanction for release of grant pertaining to the financial year is received before 31st March and the grant is actually received in the next financial year, the grant is accounted on accrual basis and an equal amount is shown as recoverable from the Grantor.
- 7.2 Government and UGC grants for meeting Revenue Expenditure (on accrual basis) are treated, to the extent utilized, as income of the year in which they are realized.
- 7.3 Unutilized grants (including advances paid out of such grants) are carried forward and exhibited as a liability in the Balance Sheet.

8. INCOME TAX:

- 8.1 The income of the University is exempted from Income Tax under Section 10(23e) of the Income Tax Act. No provision for tax is therefore made in the accounts.



आंध्र प्रदेश केंद्रीय विश्वविद्यालय की वार्षिक रिपोर्ट वर्ष 2022-2023 की समीक्षा

आंध्र प्रदेश का केंद्रीय विश्वविद्यालय भारतीय विश्वविद्यालय प्रणाली में एक विशेष स्थान रखता है। यह आंध्र प्रदेश के तेलंगाना और आंध्र प्रदेश में विभाजन की पूर्व संध्या पर आंध्र प्रदेश के लोगों की आकांक्षाओं को पूरा करने के लिए भारत सरकार द्वारा किए गए एक वादे से पैदा हुआ था। विश्वविद्यालय की स्थापना 2018 में आंध्र प्रदेश के रायलसीमा क्षेत्र के जिला मुख्यालय शहर अनंतपुरम में की गई है। इस क्षेत्र का अत्यधिक ऐतिहासिक महत्व है क्योंकि यह राजसी राजा श्री कृष्णदेवराय द्वारा शासित विजयनगर साम्राज्य का हिस्सा है। इस क्षेत्र की लोककथाएं श्री कृष्णदेवराय के जन केंद्रित शासन और कई कल्याणकारी उपायों की कहानियों से समृद्ध हैं। इसके अलावा यह क्षेत्र अपने खनिज भंडार और दक्कन के पठार की स्वास्थ्यप्रद जलवायु के लिए भी जाना जाता है। यह क्षेत्र सेरीकल्वर और बागवानी फसलों के लिए भी जाना जाता है। टोपी में एक पंख के रूप में वैश्विक ऑटो प्रमुख KIA ने अनंतपुरमु शहर से सिर्फ 60 किलोमीटर दूर एक ग्रीन फील्ड परियोजना में अपना परिचालन शुरू किया। इसके अलावा अनंतपुरमु कई इंजीनियरिंग कॉलेजों के अलावा श्री कृष्णदेवराय विश्वविद्यालय, जवाहरलाल नेहरू प्रौद्योगिकी विश्वविद्यालय, श्री सत्य साई इंस्टीट्यूट ऑफ हायर लर्निंग, गवर्नमेंट मेडिकल कॉलेज और एक सदी पुराने गवर्नमेंट आर्ट्स कॉलेज जैसे उच्च शिक्षण संस्थानों के साथ एक प्रमुख शैक्षिक केंद्र भी है।

विश्वविद्यालय उच्च शिक्षा के क्षेत्र में एक नए युग की शुरुआत करता है। नवीन सामाजिक और सांस्कृतिक रूप से प्रासंगिक शैक्षणिक कार्यक्रमों के साथ विश्वविद्यालय आने वाले वर्षों में तेजी से विकास के लिए तैयार है। मूल्य-आधारित शिक्षा के माध्यम से छात्रों को राष्ट्र के जानकार और जिम्मेदार नागरिकों में बदलना, साथ ही अनुभव के साथ इंटरैक्टिव सीखने पर जोर देना इस विश्वविद्यालय की पहचान है।

सीयूएपी ने कई नए कार्यक्रम पेश किए हैं जो विश्वविद्यालय के ट्रांजिट परिसर में सुचारू रूप से चल रहे हैं क्योंकि सीयूएपी का स्थायी परिसर अभी भी निर्माणाधीन है। वर्तमान में विश्वविद्यालय विभिन्न कार्यक्रमों पर कुल 484 छात्रों के साथ 4 यूजी और 9 पीजी कार्यक्रमों की पेशकश कर रहा है।

विश्वविद्यालय संबंधित क्षेत्रों में सेवानिवृत्त संकाय, वरिष्ठ संकाय, विशिष्ट संकाय, अतिथि संकाय और विभिन्न संगठनों / संस्थानों के विशेषज्ञों को नियुक्त करके अपने शैक्षणिक कार्यक्रम चला रहा है।

आंध्र प्रदेश सरकार, राज्य एनएसएस सेल, उच्च शिक्षा विभाग, भारत सरकार ने एनएसएस सेल की स्थापना की अनुमति प्रदान की। विश्वविद्यालय ने ट्रांजिट कैंपस- II, बेल्लारी रोड, अनंतपुरमू में अपने परिसर में शुरू करने के लिए प्रत्येक 100 छात्रों की दो ईकाइयों के साथ एनएसएस सेल की स्थापना की।

दृष्टि:

- विश्वविद्यालय ने एनईपी 2020 का गहन अध्ययन किया और नीति की आवश्यकताओं के अनुसार अपने पाठ्यक्रम में उपयुक्त बदलाव किए।

 - विश्वविद्यालय ने 4 अगस्त 2022 को "मोदी @ 20: ड्रीम्स मीट डिलीवरी" पुस्तक पर एक अंतर्राष्ट्रीय चर्चा की मेजबानी की। मुख्य अतिथि श्रीमती अन्नपूर्णा देवी, माननीय केंद्रीय राज्य मंत्री, शिक्षा मंत्रालय, भारत सरकार और सम्मानित अतिथि श्री ए.एस. किरण कुमार, पद्म श्री पुरस्कार से सम्मानित और पूर्व अध्यक्ष इसरो, और श्रीमती अपोलो हॉस्पिटल्स की वाइस चेयरपर्सन शोभना कामिनेनी ने प्रतिभागियों को संबोधित किया। परिचर्चा में विद्यार्थियों व शिक्षकों ने बढ़-चढ़कर हिस्सा लिया।
 - आंध्र प्रदेश के केंद्रीय विश्वविद्यालय ने उन्नत भारत अभियान के तहत छह गांवों को गोद लिया है। एक भारत श्रेष्ठ भारत कार्यक्रम के तहत, इसने पंजाब केंद्रीय विश्वविद्यालय के साथ एक समझौता ज्ञापन पर हस्ताक्षर किए हैं और पंजाबी में तेलुगु कविताओं के दो संकलनों का सफलतापूर्वक अनुवाद किया है। विश्वविद्यालय ने आजादी का अमृत महोत्सव के हिस्से के रूप में कार्यक्रमों की एक श्रृंखला भी आयोजित की, जिसमें विश्वविद्यालय द्वारा गोद लिए गए दो गाँव जंधुलुरु और रेड्डीपल्ली में "हर घर तिरंगा" कार्यक्रम शामिल है, "विभाजन की भयावहता की स्मृति" की याद में एक पोस्टर प्रदर्शनी "भयावहता की दीवार" दिवस, भारत के स्वतंत्रता संग्राम पर दूसरा और दूसरा "चुनावी भागीदारी और राजनीतिक अधिकारिता" पर। इसके अलावा, एक संगोष्ठी "प्रस्तावना, लोग, राजनीति" भी आयोजित की गई थी। छात्रों और कर्मचारियों ने क्लॉक टॉवर से अनंतपुरम् शहर में नगरपालिका कार्यालय तक एक फ्लैग मार्च भी किया, जिसे जनता द्वारा बहुत सराहा गया और मीडिया में व्यापक कवरेज मिली।






डॉ. भीमराव रामजी अम्बेडकर (1891-1956), जिन्हें प्यार से बाबासाहेब के नाम से जाना जाता है, भारत के सबसे प्रसिद्ध पुत्रों में से एक और एक महान राष्ट्रीय नेता हैं। उन्हें दलितों के लिए चैपियन, एक विद्वान विद्वान, असाधारण राजनेता और एक दूरदर्शी के रूप में माना जाता है जिन्होंने आधुनिक राष्ट्र के निर्माण में बहुत योगदान दिया। डॉ. अम्बेडकर ने भारत के इतिहास में एक मसीहा के रूप में एक अमिट छाप छोड़ी, जिन्होंने उन उत्पीड़ित वर्गों को मुक्त किया जो अपने सार में पथ-प्रदर्शक थे और स्वतंत्रता के स्मारकीय प्रयासों के लिए प्रयासरत थे। वह भारत के संविधान के मुख्य शिल्पकार थे, जिसमें बाबासाहेब ने उत्पीड़ित वर्गों के न्याय और सशक्तिकरण के लिए मुक्तिदायी प्रावधान छोड़े थे। वह भारत में कमज़ोर और दलित आबादी के न्याय और सशक्तिकरण के लिए संघर्ष के प्रतीक हैं और एक न्यायपूर्ण समाज के निर्माण की आधारशिला रखते हैं। बाबासाहेब के ज़बरदस्त विचारों के कारण ब्रिटिश शासन के दौरान भारतीय रिझर्व बैंक का गठन हुआ। एक श्रमिक नेता के रूप में, उन्होंने "काम की उचित स्थिति" के विपरीत "श्रम के जीवन की उचित स्थिति" के क्रांतिकारी विचार को बढ़ावा दिया, जिसने भारत में भविष्य के श्रम कानूनों की रूपरेखा प्रदान की। बाबासाहेब लैंगिक समानता के पक्षधर भी थे क्योंकि उन्होंने काम के घंटों को घटाकर प्रति सप्ताह 48 घंटे करने के लिए सुधार शुरू किए, महिलाओं को रोजगार के विभिन्न रूपों में शामिल करने पर लगे प्रतिबंध को हटा दिया और "समान काम के लिए समान वेतन" के सिद्धांत को कोडित किया। लिंग की परवाह किए बिना। हिंदू कोड बिल का उनका विचार अनुकरणीय प्रकृति का है। बाबासाहेब ने महाड सत्याग्रह, खोती विरोधी आंदोलन और दलित बौद्ध आंदोलन जैसे आंदोलनों में अपनी भूमिका के माध्यम से एक समाज सुधारक के रूप में एक स्थायी छाप छोड़ी।

शासी निकाय के निर्णयों के अनुसरण में, योजना का उद्देश्य कम से कम 30 केंद्रीय विश्वविद्यालयों में डॉ. अम्बेडकर उत्कृष्टता केंद्र स्थापित करना है, भारत के प्रत्येक राज्य/संघ राज्य क्षेत्र से एक। योजना के माध्यम से, केंद्र अनुसूचित जाति के छात्रों को सर्वोत्तम और मुफ्त कोचिंग सुविधाएं प्रदान करके प्रतियोगी परीक्षाओं में सशक्त करेगा।

सीयूएपी ने छात्रों को अत्याधुनिक सुविधाएं प्रदान कीं और स्वीकृत संख्या 100 में से 99 छात्रों को कोचिंग के लिए नामांकित किया गया। केंद्र का उद्घाटन 1 अक्टूबर 2022 को केंद्रीय विश्वविद्यालय के अनंतपुरमु मुफ्त कोचिंग कार्यक्रम से माननीय संसद सदस्य श्री तालारी रंगैया द्वारा किया गया था। JNTU रोड, अनंतपुरमू पर विश्वविद्यालय के अंतरिम परिसर में आंध्र प्रदेश। कार्यक्रम का उद्घाटन करते हुए श्री रंगैया ने कार्यक्रम के छात्रों की छात्रावास सुविधा और वजीफा मुद्दों को सामाजिक न्याय और अधिकारिता मंत्री, भारत सरकार के पास ले जाने और छात्रों को आगे सुविधा प्रदान करने के लिए अपनी पूरी कोशिश करने का वादा किया।

इस कार्यक्रम के सम्मानित अतिथि डॉ. फकीरप्पा कागिनेली, आईपीएस, पुलिस अधीक्षक, अनंतपुरम जिले ने छात्रों को एसपी कार्यालय द्वारा स्थापित डिजिटल लाइब्रेरी का उपयोग करने की सलाह दी और कभी-कभी कक्षाएं लेने के लिए स्वेच्छा से और सिविल सेवा की तैयारी के लिए छात्रों को भी प्रेरित किया। आंध्र प्रदेश के केंद्रीय विश्वविद्यालय में डॉ. अम्बेडकर सेंटर फॉर एक्सीलेंस (डीएसीई) का मुफ्त कोचिंग कार्यक्रम।





SCHEDULE: 23 SIGNIFICANT ACCOUNTING POLICIES

1. BASIS FOR PREPARATION OF ACCOUNTS

- 1.1 The accounts are prepared under the Historical Cost Convention unless otherwise stated and generally on the accrual method of accounting.

2. REVENUE RECOGNITION

- 2.1 Fees from Students (except Tuition Fees), Sale of Admission Forms, Royalty and Interest on Savings Bank account are accounted on cash basis. Tuition Fees collected separately for each semester is accounted on accrual basis.
- 2.2 Income from Land, Buildings and Other Property and Interest on Investments (except of Endowment Funds) are accounted on accrual basis. Investments against most individual Endowment Funds are small and moreover, presenting the income with inclusion of accrued interest would also not reflect correctly the amount actually available for expenditure on the objects of the respective funds.

3. FIXED ASSETS AND DEPRECIATION

- 3.1 Fixed assets are stated at cost of acquisition including inward freight, duties and taxes and incidental and direct expenses related to acquisition, installation and commissioning.
- 3.2 Gifted and Donated assets are valued at the declared value where available if not available the value is estimated based on the present market value and the physical condition of the asset. They are set-up by credit to Capital Fund and merged with the Fixed Assets of the University. Depreciation is charged at the rates applicable to the respective assets.
- 3.3 Fixed assets are valued at cost less accumulated depreciation. Depreciation on fixed assets is provided on written down value method, at the following rates:

4. INTANGIBLE ASSETS

- 4.1 **PATENTS:** The expenditure incurred from time-to-time (application fees, legal expenses etc.) for obtaining Patents is temporarily capitalized and shown as a distinct head in the Balance Sheet. If applications for patents are rejected the cumulative expenditure incurred on the particular patent is written off to the Income & Expenditure Account in the year the application is rejected. The expenditure on Patents granted is written off over a life of 9 years on a conservative basis.
- 4.2 **ELECTRONIC JOURNALS (E-Journals):** Electronic Journals (E-Journals) are separated from Library Books in view of the limited benefit that could be derived from the on-line access provided. Though E-journals are not in a tangible form, they are temporarily capitalized in view of the magnitude of expenditure and the benefit derived in terms of perpetual knowledge acquired by the Academic and Research Staff; Depreciation is provided in respect of E-journals at a higher rate of 40% as against depreciation of 10% provided in respect of Library Books.
- 4.3 **COMPUTER SOFTWARE:** Expenditure on acquisition of software has been separated from computers and peripherals, as apart from being intangible assets, the rate of obsolescence in respect of these is very high. Depreciation is provided in respect of software at a higher rate of 40% as against depreciation of 20% provided in respect of Computers & Peripherals.
- 4.4 **SUBSCRIPTION OF JOURNALS:** The subscriptions for more than one Journal in a single payment for a period of one year or less for which subscription periods are differently overlapped with the current year are booked as current year expenditure.
5. **STOCKS:**
- 5.1 Expenditure on purchase of chemicals, glassware, publications and other stores is accounted as revenue expenditure, except that the value of closing stocks held on 31 March is set up as inventories by reducing the corresponding Revenue Expenditure on the basis of information obtained from Schools and Departments.

6. INVESTMENTS:

- 6.1 Long term investments are carried at their cost or face value whichever is lower. However, any permanent diminution their value as on the date of the Balance Sheet is provided for.
- 6.2 Short Term investments are carried at their cost or market value (if quoted) whichever is lower
- 6.3 Savings Bank Accounts with auto sweep facility, generate interest according to the duration for which the funds are auto swept from time to time. The interest income in such saving bank accounts is accounted for only on receipt basis.

7. GOVERNMENT AND UGC GRANTS:

- 7.1 Government Grants and UGC grants are accounted on realization basis. However, where a sanction for release of grant pertaining to the financial year is received before 31st March and the grant is actually received in the next financial year, the grant is accounted on accrual basis and an equal amount is shown as recoverable from the Grantor.
- 7.2 Government and UGC grants for meeting Revenue Expenditure (on accrual basis) are treated, to the extent utilized, as income of the year in which they are realized.
- 7.3 Unutilized grants (including advances paid out of such grants) are carried forward and exhibited as a liability in the Balance Sheet.

8. INCOME TAX:

- 8.1 The income of the University is exempted from Income Tax under Section 10(23e) of the Income Tax Act. No provision for tax is therefore made in the accounts.
